- (1) The Issuer's American depositary shares are listed on the NASDAQ Global Market under the symbol "ICLK." Two American depositary shares represent one Class A ordinary share of the Issuer.
- (2) Czemy Holdings Limited acquired directly from the Issuer 1,125,926 ordinary shares and 49,606 ordinary shares, respectively, on January 26, 2011 and May 1, 2013. In January 2015, Czemy Holdings Limited sold 287,916 ordinary shares. During the Issuer's initial public offering in December 2017, the remaining ordinary shares held by Czemy Holdings Limited were reclassified as 887,616 Class A ordinary shares.
